As part of the Share Repurchase, for the period between 8 November 2021 and 12 November 2021, Prosus repurchased 2 654 012 Prosus ordinary shares N at an average price of €72.7530 per share for a total consideration of €193 087 367.91 (US\$ 223 050 759.75).
